The Information We Collect and How We Use It

TRS may collect your personal details, including but not limited to your name and contact details and other relevant information from your CV, supplied by you or in the public domain. This information is held, used and disclosed by us as follows:

1. to provide our recruitment services to you;
2. to maintain our business relationship, where you are a user of our website / services, whether a client or candidate;
3. to enable you to submit your CV for general applications, to apply for specific jobs or to subscribe to our job alerts or other e-news (Please see the separate section on your CV below which outlines additional uses and disclosures);

10. to trusted third parties where we have retained them to provide services that you or our clients have requested, such as reference, qualification and criminal reference checking services (as required), verification of the details you have provided from third party sources, psychometric evaluations or skills tests;
11. to third parties who perform functions on our behalf and who also provide services to us, such as IT consultants and developers carrying out testing and development work on our business technology systems, research and mailing houses and recruitment coordinators. (These third parties comply with similar undertakings of privacy and confidentiality as TRS);
12. we may also release personal information to regulatory or law enforcement agencies, if required to do so by law;

Your information, whether private or public will not be sold, exchanged, transferred or given to any other party for any reason whatsoever unless specifically for recruitment services to you and not without your consent unless required by law.
